

PRIVACY NOTICE

This privacy notice discloses the privacy practices for Luggary.com. This privacy notice applies solely to information collected by this website. It will notify you of the following:

What personally identifiable information is collected from you through this website,
How the personally identifiable information collected here is used and with whom it may be shared.
What choices are available to you regarding the use of your data on this site.
The security procedures in place to protect the misuse of your information from this site.
How you can correct any inaccuracies in the information collected.
How policy changes here will be communicated.

WHAT PERSONAL INFORMATION LUGGARY COLLECTS.

When you register on Luggary you are required to provide us an email address. To rent or purchase any item or service on our Sites you must also provide us with your full legal name, and a full street address including city, state and zip code, and telephone number. To protect ourselves and our customers from fraud, we may also collect additional information about our registered users from credit bureaus and other consumer information services.

Every time you use our service, we collect information about your usage. For example, Luggary collects information regarding the products you browse and the orders you place on our Sites. If you contact us by letter, phone, online chat, or email, Luggary will collect your sender information and may collect the other information you voluntarily disclose to us and may contact you via email in the future to tell you about specials, new products or services or changes to this privacy policy.

Luggary does not collect a customer's credit card information. All credit card information provided to us is collected and stored by a authorized third party that processes payment.

How Luggary Collects Information About You.

Luggary is the sole owners of the information collected on this site. We only have access to/collect information that you voluntarily give us via email or other direct contact from you.

Luggary collects information in the following ways about its luggage customers:

We collect information that our luggage customers supply to us directly, such as in forms on our Sites or phone calls we receive from you.

We collect information from emails and other contacts sent to us by our customers and users of our Sites.

We collect information electronically on all users of our Sites, including customers, by means of cookies.

Your Access to and Control Over Information.

You may opt out of any future contacts from us at any time. You can do the following at any time by contacting us via the email address or phone number given on our website:

We take precautions to protect your information. When you submit sensitive information via the website, your information is protected both online and offline.

Wherever we collect sensitive information that information is encrypted and transmitted to us in a secure way. You can verify this by looking for a closed lock icon at the bottom of your web browser, or looking for “https” at the beginning of the address of the web page.

We do not store or collect customer credit card data. All credit card data collected and stored is through a secure third party that processes payment.

While we use encryption to protect sensitive information transmitted online, we also protect your information offline. Only employees who need the information to perform a specific job (for example, billing or customer service) are granted access to personally identifiable information. The computers/servers in which we store personally identifiable information are kept in a secure environment.
